

**TORREY TOWN, WAYNE COUNTY, UTAH**  
**RESOLUTION NO.**

**A RESOLUTION RELATING TO THE CULINARY WATER  
SYSTEM OF TORREY TOWN AFFECTING  
CONNECTIONS.**

WHEREAS, Torrey Town operates a culinary water system and under its Ordinances, the Town by Resolution may provide from time to time changes in regulations concerning the water system;

**NOW THEREFORE, IT IS HEREBY RESOLVED BY THE MAYOR AND TOWN COUNCIL OF TORREY TOWN, WAYNE COUNTY, UTAH, AS FOLLOWS:**

This Resolution is for the purpose of amending Sections 18 and 21 of Resolution No. 2008-1 adopted May 8, 2008.

**Section 1.** Section 17, Annual Limitation on Water Connections is hereby amended by the Mayor and Town Council to read and provide as follows:

17. Annual Limitation on Water Connections. The Town reserves the right to limit the number of water connections issued on an annual basis or otherwise. Any changes to applicable ordinances or polices shall be made by resolution.

**Section 2.** Section 18, Time Periods for Filing Applications is hereby amended by the Mayor and Town Council to read and provide as follows:

18. Filing of Applications. Applications for water connections may be filed with the Town at any time, provided that the installation of water meters and related equipment and accessories shall be subject to weather conditions and the availability of Town staff and equipment. Applicants are encouraged to file application prior to October 1 of a given year due to the higher probability that installation will be delayed by weather conditions.

**Section 3.** Section 21, Applications Held on File – Priority is hereby repealed and deleted in its entirety.

**Section 4. Effective Date and Posting.** This Resolution shall take effect immediately and following posting thereof in the following three (3) conspicuous places within the Town:

1. Torrey Town Hall, 55 East 100 North, Torrey, Utah
2. Torrey Post Office
3. Chuck wagon General Store
